BECHUANALAND PROTECTORATE AFRICAN IMMIGRATION
PROCLAMATION, 1958.

APPLICATION FOR A PERMIT FOR PERMANENT RESIDENCE IN THE BECHUANALAND PROTECTORATE.

- Note.--(a) The information required hereunder must be given in ENGLISH.
 (b) If the reply to any of these questions is in the negative it must be clearly stated.
 (c) This form is to be declared before a British Consul or a Magistrate, Justice of the Peace, Notary Public, or Commissioner of Oaths.
 (d) If application is in respect of a child under 18 years of age this form should be completed personally--
 (i) if the child is to reside in the Territory with a parent, guardian, or relative of the child; by that parent, guardian or relative.
 (ii) otherwise; by the father or guardian of the child.
 (e) A separate form need not be completed where the applicant for a Permit for(a) child(ren) also makes application for a Permit for himself.

Warning.--any person knowingly giving false information or making a false declaration, is liable to penalties of fine and imprisonment.
