

The digital preservation lifecycle refers to all of the stages required to preserve and sustain access to digital content; from creation to ingest, management and administration to access and reuse.

Digitisation

It is the process of taking traditional library materials, that are in the form of books and papers and converting them to the electronic form, where they can be stored and manipulated by a computer.

Digital Preservation

The processes and operations in ensuring the technical and intellectual sustainability of digital content through time, to maintain access to digital materials beyond the physical media, format or technological obsolescence.

It requires policies, planning, resource allocation (funds, time, people) and appropriate technologies and actions to ensure accessibility, accurate rendering, and authenticity of digital content.




WHY WE DIGITISE

- · Increase the possibilities for innovative research











Selection of brittle unique archival materials to digitise for preservation purposes






Preparation for digitisation includes retrieval of the items from the shelves, removal of staples, pins, cello tape, repairing tears and broken corners, etc.




Selection of African Language theses and dissertations from the shelves to preserve African Indigenous content




